## Judge Profiles

### Linden Sly

Linden has farmed all his life, and has been breeding stud Dairy Goats since the early '70s, starting his Tollendool Angora Strud in 1974 (until the mid-90s), and his current studs Tollendool Toggenburgs and Tollendool Saaneens in 1978 and 1984 respectively.

Linden has had great success showing at the Royal Melbourne Show, Royal Adelaide Show and Royal Canberra Show, and continues to show regularly throughout northern Victoria and the Riverina.

Linden joined the Judges' Panel in 1985, and was placed on the Australian Judges' Panel in 1994. Linden's judging experience includes the Sydney Royal Easter Show, the Royal Hobart Show, the Ekka, and numerous Dairy Goat Society Branch Shows in Victoria, New South Wales, South Australia and Queensland. During the Sydney Royal Easter Show, Linden is the Ring Announcer for the Dairy Goat Competition.

Linden and his wife Heather are part of three generations of Dairy Goat Breeders, and have two children and two grandchildren.

### Vicki Mitchell

Vicki has been involved with Boer Goats for over 15 years as a joint owner of Coomboona Boer Stud with her husband Geoff, and as partner of Mitchell SA Genetics since 2002. Vicki currently runs 300 full-blood Boers and 100 Dorper sheep on 380 acres at Coomboona, northern Victoria.

Vicki is the current Chair and Breed Development director for the Federal Board of the Boer Goat Breeders' Association of Australia, and has held a position on the Federal board for five years.

Currently a level 3 judge, Vicki's previous judging experience includes the Royal Geelong Show, Royal Hobart Show, Royal Adelaide Show, Royal Brisbane Show, World Championships (Hamilton NZ), and the Southern Aurora Boer Championships (Goulburn). She's co-judged with Saakie Nell (South Africa) and Celia Burnett - Smith (Qld).

# LIVESTOCK EXHIBITORS PUBLIC LIABILITY INSURANCE

## EXPLANATION

WHEREAS The Royal Agricultural Society of Victoria Ltd has agreed to effect a Public Liability insurance for certain Animal Exhibitors at the 2013 Royal Melbourne Show, the following applies:

<b>Insured Party:</b>	Animal and Livestock Exhibitors participating in competitions and events
<b>Period of Insurance:</b>	From seven days prior to the Show until seven days thereafter.
<b>Insured Activities:</b>	All activities undertaken whilst within and from the confines of the event venue consistent with the Insured's livestock exhibit activity including setting up and removal
<b>Description of Cover:</b>	Insurance in respect of the Insured Party's liability to pay costs and compensation in respect of loss of or damage to third party property and death of or injury to third party persons caused by and arising out of the Insured activities, all subject to the RASV's policy terms, conditions, exclusions and warranties, etc.
<b>Amount of Cover:</b>	\$10,000,000 any one occurrence
<b>Deductible:</b>	\$10,000 any one occurrence
<b>Geographic Limits:</b>	At and from the event venue
<b>Claims Payable:</b>	Worldwide excluding claims made USA and Canada
<b>Insurer(s):</b>	Primary - \$10,000,000 Lloyds of London
<b>Address:</b>	C/- Insurance market Facilities Pty Ltd., L16 383 Kent Street, Sydney, NSW, 2000.
<b>Policy Numbers:</b>	10331X12(A)

## IMPORTANT CONDITIONS

1. The Insured Party must exercise reasonable care to maintain all premises, fittings and plant in sound condition.
2. The Insured Party must take all reasonable precautions to prevent injury and damage to persons and property.
3. The Insured Party must give immediate notice of an incident which may give rise to a claim or of receipt of advice of a claim.
4. The Insured Party must not make any admission, offer or promise in connection with any claim and must not at any time admit liability.
5. The Insured Party must make themselves aware of and comply with the following Notices:-
  - (a) **Duty of Disclosure:** Before you enter into a contract of General insurance with an insurer, you have a duty, under the Insurance Contracts Act 1984 as amended, to disclose to the insurer every matter that you know, or could reasonably be expected to know, is relevant to the insurer's decision whether to accept the risk of the insurance and, if so, on what terms.  
You have the same duty to disclose these matters to the insurer before you renew, extend, vary or reinstate a contract of General insurance.  
Your duty however, does not require disclosure of matter:
    - \* that diminishes the risk to be undertaken by the insurer
    - \* that is of common knowledge
    - \* that your insurer knows or, in the ordinary course of his business, ought to know.**Non-Disclosure:** If you fail to comply with your duty of disclosure, the insurer may be entitled to reduce his liability under the contract in respect of a claim or may cancel the contract.  
If your non-disclosure is fraudulent, the insurer may also have the option of avoiding the contract from its beginning.
  - (b) **Average Provision:** The insurer will pay legal expenses in addition to the sum insured, if however, the total amount of the loss (less legal expenses) ultimately paid to the claimant(s) exceeds the sum insured then insurers will only pay (in addition to the sum insured) that proportion of the legal expenses as the sum insured bears to the loss.
  - (c) **Third Party Interests:** This policy will only provide cover for your interest and does not cover the interests of any third party (e.g. financiers, lessors, etc) unless the interests of the third party are noted in the policy.
  - (d) **Waiver of Insurer's Rights:** You must not enter into any agreement without the written authority of the insurer whereby any of their rights to which they become entitled as your insurer after settling or agreeing to settle a claim are prejudiced or limited in any way otherwise all benefit under the policy will be forfeited.

3. Nothing herein shall be construed to alter in any way the scope of insurance policy, its terms, conditions or exclusions, issued by insurers.
4. RASV is not liable to the Insured Party in the event a claim is not paid or payable by Insurers unless RASV fails to take reasonable steps to advise that the cover is or is likely to be cancelled or not renewed.
5. RASV is not an Australian Financial Services (AFS) Licence holder. RASV is not providing financial product advice, has not considered the particular needs of the Insured party and no statement is intended to influence a person or persons making a decision in relation to any insurance cover. You should consider obtaining your own financial product advice from a person holding the appropriate AFS licence.
6. THIS INSURANCE ONLY APPLIES TO INSURED PARTIES ENTERING COMPETITION IN ACCORDANCE WITH THE GENERAL REGULATIONS.

Entries are due at the Superintendent's Office by **9am Saturday 21 September**.

## STRAW AND BEDDING

## HEALTH STATUS DECLARATION AND CHANGES TO THE OJD MANAGEMENT PLAN

The new National OJD Management Plan 2013 comes into effect from July 1

The Royal Melbourne Show will continue to conduct its animal health and biosecurity practices to the highest of standards, and will ensure all operations are in line with the National OJD Management Plan.

Exhibitors are required to complete both a Sheep Health Declaration and a National Sheep Health Statement, and submit these forms when entering. Copies are available for download from [www.rasv.com.au/sheep](http://www.rasv.com.au/sheep).

Please take time when completing your Health Declaration and Sheep Health Statement, as this information will be used to comply with penning and biosecurity requirements.

Should you wish to download and print the Catalogue prior to arrival, you will not be required to purchase one.

Catalogues are still available for purchase on your Entry Form should you wish, and will be included in your Exhibitor Pack.

Additional Catalogues may be purchased from the Superintendent's Office during the Show.

## ACCOMMODATION LOCKERS

Accommodation Lockers will be available for Exhibitor use. The RASV reserves the right to limit locker allocation in an effort to accommodate all Exhibitors.

A key deposit will apply for the use of Accommodation Lockers during Show, with the deposit to be refunded upon return of the key. Lockers measure 1.8m x 2.4m.

## PROPERTY IDENTIFICATION CODE

The Property Identification Code of the Melbourne Showgrounds is 3MWAG001.

## PROMOTIONAL SPACE

If there is sufficient space, the RASV shall make space available to those Breed Societies and Associations that apply, for the purpose of providing marketing and educational material pertaining to that breed. These spaces will not be made available to individual studs. Only one space per breed will be granted and only if space permits. The RASV reserves the right to select the occupier of said space.

We invite breed societies and associations to contact the RASV in relation to breed promotional material for the judging ring.

## CONSOLIDATION OF CLASSES

In order to create competition, please be aware that classes may be amended or consolidated once entries have closed. Refer to Regulation 105 of the Sheep Competition or Regulation 304 of the Goat Competition for more information.

# REGULATIONS OF GOAT COMPETITION

301. The Regulations appearing in this Schedule form part of the General Regulations and conditions of entry to an Event at the Royal Melbourne Show. In the event of any inconsistency between the General Regulations and these Regulations, the General Regulations shall prevail to the extent of the inconsistency unless the General Regulations provide otherwise.

## CLOSE OF ENTRIES

302. Entries in the Goat competition must be received by the RASV Administration Offices, Melbourne Showgrounds, Epsom Road, Ascot Vale, Victoria 3032 by no later than 5:00pm on Friday 9 August 2013. All entries must be accompanied by the applicable fee and health status declaration form.

303. The onus is entirely on the Exhibitor to submit particulars on time. There will be no reminder from RASV staff.

304. In accordance with General Regulation 8.2, to create competition the RASV reserves the right to amend, consolidate or cancel classes offered in this competition schedule

## SUBSTITUTIONS

305. Exhibitors have the option to nominate substitute entries, of which all details must be completed in the space provided on the Entry Form. If an exhibitor wishes to exhibit a substitute animal in lieu of the original nomination, advice in writing must be in the hands of the RASV no later than 5:00pm Friday 17 August 2012.

## ENTRY FEES

306. Entry Fees for Goat breeds are as follows (straw inclusive):

Per animal	\$25 per entry (GST free) for Members
	\$38 per entry (GST free) for Non-Members

307. This entry fee entitles the Exhibitor to enter the animal in all eligible classes. Please specify selected classes on enclosed Entry Form.

## TRUCK PARKING

308. Parking for trucks and floats will be available. Apply by completing the relevant section on the Entry Form and forward the fee with the competition entry fee.

309. Truck parking fees are as follows:

310. Please indicate on the Entry Form the make/model of your truck/trailer.

311. There is to be no camping in the truck park under any circumstances.

312. Any vehicle, including trucks, stock transports, trailers, and horse floats, located on the Showgrounds, or any area leased by the RASV, shall be at the sole risk of the owner. The RASV accepts no responsibility for any loss or damage, including loss or damage caused by negligence of the RASV, its officers, employees, or agents to any vehicle, or the contents of any vehicle, located on the RASV's property or in the area leased by the RASV.

## ARRIVAL AND DEPARTURE OF EXHIBITS

313. All Goat Exhibitors are to comply with the following arrival and departure timings, unless otherwise notified directly by the RASV.

314. Arrival and Departure times are as follows:

### Boer Goats:

Arrival: Friday 20 September, 9:00am – 6:00pm  
 Departure: Sunday 22 September, 6:00pm – 10:00pm

### Dairy Goats:

Arrival: Sunday 22 September, 6:00pm – 7.30pm OR  
 Monday 23 September, 5:00pm – 7.30pm OR  
 Tuesday 24 September, 6:00pm – 7.30pm  
 (exhibitors are requested to nominate their preferred arrival time on their entry form).

Departure: Wednesday 25 September 2013 between 6:00pm and 9:00pm.

315. Priority may be given to Exhibitors that have considerable distance to travel.

## PERIOD OF EXHIBITION

316. All Goats are required to be in their correct pens by 8:00pm on day of arrival and prior to strip outs.

## ACCOMMODATION LOCKERS

317. Accommodation Locker prices are \$120.00 (\$100.00 GST inc.) of which \$20.00 (GST free) is a key deposit. On return of Locker Key a refund will be issued. Due to limited Accommodation Lockers, we reserve the right to limit allocation in an effort to accommodate all Exhibitors.

## BEDDING

318. No bedding other than straw may be used in pens.

319. For the convenience of Exhibitors, fodder merchants will attend the Showgrounds for the purpose of accepting orders for stock foods, etc and the delivery of food stocks must be made before 8:00am each day during the Show.

## STOCK ATTENDANT PASSES

320. A Confirmation of Entries will be issued prior to the Show.

321. The Confirmation of Entries document must be produced at the gate, when it will admit the Exhibitor and Exhibits on to the Showgrounds. It must be retained, and again produced when the Exhibit leaves the Showgrounds. Stock Attendant Passes will be issued by the Superintendent at his office on the Showgrounds once Exhibits have been penned.

322. Stock Attendant Passes will be issued according to the following formula:

- One Stock Attendant Pass for every Exhibitor.
- Additionally: One Stock Attendant Pass for three to five Exhibits
- Two Stock Attendant Passes for six to ten Exhibits
- Three Stock Attendant Passes for eleven or more Exhibits.

## CLEANLINESS OF PENS

323. Mucking out of pens is to be carried out between 8:00pm and 7:00am. These times will be strictly enforced.

324. Exhibitors must keep the pens allotted to their animals clean and give proper attention to their stock throughout the Show. Cleaning of pens occupied by Exhibits must be completed before 7:00am each day.

## ADVERTISING

325. Exhibitors are permitted to display cards over the pens allotted to them stating that an animal is for private sale. These cards are not to exceed 30cm x 25cm. No other advertisement or notices (except by permission of the RASV) are permitted on or in any stalls or buildings.

326. Each Exhibitor is permitted to display one sign 60cm x 120cm in size provided that such sign carries only the stud name, address, telephone number, facsimile number, e-mail address and website address.

## SMOKING

327. Smoking and naked flames are at all times prohibited in Lockers and Pavilions.

## REGISTRATION

328. All goats entered in this Section must be registered in a herd book recognised by the RASV or recorded in the appendix sections of a herd book recognised by the RASV.

## HEALTH REGULATIONS

329. All Goat entries must be accompanied by a signed National Goat Health Statement and goats must have a minimum assurance rating of two.

330. The Royal Melbourne Show Goat Competitions will be conducted under the guidelines as set out in the Johne's Disease Market Assurance Program (GoatMAP).

## CAPRINE ARTHRITIS ENCEPHALITIS (CAE)

331. Dairy Goats will not be permitted to enter the Showgrounds unless Exhibitors provide a Veterinary Certificate to the effect that the goats to be exhibited:

- a) are from a CAE accredited free herd or;
  - b) have had a least one negative ELISA test after 1 January 2012, and show no clinical signs of the virus or;
  - c) have had at least one (1) negative test after 1 January 2012 for Johne's Disease and show no clinical signs (for goats over 12 months).
- These certificates must be submitted to the RASV office by Friday 27 July 2012 or the relevant entries will be cancelled.

**NATIONAL LIVESTOCK IDENTIFICATION SCHEME (NLIS)**

332. All meat and fibre producing goats are required to be NLIS tagged when attending the Show. Dairy Goat breeds are exempt from NLIS tagging requirements.

**UNSAFE EXHIBITS**

333. If, in its absolute discretion the RASV determines any Exhibit or Exhibits to be dangerous, for any reason whatsoever, the RASV may by notice to the Exhibitor require the animal, or animals concerned, to be forthwith removed from the Showgrounds. The Exhibitor, upon receipt of such notice, shall forthwith remove such animals and failing such removal by him within the time prescribed by the RASV, the RASV may remove the animal or cause the animal to be removed and all costs and expenses of removal shall be borne by the Exhibitor and shall be refunded to the RASV.

**IN MILK AND DRY CLASSES**

334. A fee will be charged for each Doe competing in the milk test for the testing of the samples.

335. A Doe entered as "in milk" can be transferred to a "dry" or un-kidded class, whichever is applicable, if she has not kidded prior to judging day, and vice versa.

336. Does must be fully milked out and stripped dry at 8:00pm in the presence of the Stewards or whomever they may appoint, on the night prior to judging. The owner or his/her representative must be in attendance when females are being stripped dry.

337. The procedures for conducting the 24-hour Milk Production Tests are as recommended by the Dairy Goat Society of Australia.

338. Exhibitors in the 24-hour Milk Production classes are required to advise the Stewards of:

- a) the number of lactations completed by each Doe,
- b) last date of kidding or abortion.

339. Judges have the absolute right to order any Doe competing for Championships to be milked dry before finally awarding the prizes.

**SUCKLED KIDS**

340. Kids not entered for competition will be permitted on the Showgrounds on the provision they are actually being suckled by mothers entered for competition.

341. Exhibitors may provide their own mesh or similar, to create their own kid areas within their penning areas, prior to the 24 hour Milk Test and judging day, if required, for kids brought in suckling their dams.

**INSPECTION OF EXHIBITS**

342. Each breed society or association shall put forward nominations for Inspector appointments for their breed and these nominations will be considered by the RASV.

343. Every animal exhibited in the Goat section will be subject to inspection carried out by an Inspector appointed by the RASV.

344. Without prejudice to any other applicable regulations, if the relevant Inspector determines, or the relevant Inspectors unanimously determine that any animal entered for competition:

- a) is not true to type; or
- b) is not of sufficient merit as to be worthy of exhibition in the class or classes for which it is entered; or
- c) has not been adequately prepared for the Show; or
- d) bears any marking brand or tattoo inconsistent with either the markings brand or tattoo disclosed in the relevant Entry Form or any marking brand or tattoo not in accordance with the records of the relevant Breed Society, then such animal shall be deemed to be ineligible for exhibition at the Show and the RASV may by notice to the Exhibitor, require the animal to be forthwith removed from the Showgrounds. The Exhibitor, upon receipt of such notice, shall forthwith remove such animal and failing such removal by him within the time prescribed by the RASV, the RASV may remove the animal or cause the animal to be removed and all costs and expenses of removal shall become by the Exhibitor and shall be refunded to the RASV.

345. Exhibitors are required to have their stock attended and in readiness for inspection on request.

346. Without prejudice, the determination of the Inspectors or of the Veterinary Surgeons on any matter shall be subject only to appeal to the Chief Steward in the Goat section, who shall make such determinations and directions as they think fit, which determinations and directions shall be final and shall not be called into question in any proceedings or in any manner whatsoever. The Inspector, Veterinary Surgeons or Chief Steward shall not be required to furnish to the Exhibitor any reasons for their determination or directions or to give to the Exhibitor any right to be heard on any matter in question.

347. Any animal entered, which can be proved to the satisfaction of the RASV to have received hormones, shall be disqualified. The decision or determination of the RASV shall be final and shall not be called into question in any proceeding or in any manner whatsoever.

**TAMPERING OF EXHIBITS**

348. It is the Exhibitor's responsibility to ensure the animal is not subject to prohibited practices, prior to and whilst on the Showgrounds.

349. The RASV may make or cause to be made, any test of any Exhibit to determine whether any drug or other substance has been administered to the Exhibit and may take possession of any such Exhibit for any of the aforesaid purposes and detain such Exhibit for such period as the RASV deems necessary. Procedures for the testing of prohibited substances may include random tests on Exhibits.

350. Should a positive test to a prohibited substance or practice result, any costs associated with testing will be borne by the Exhibitor.

351. In accordance with General Regulation 7.1, should a positive test to a prohibited substance or practice result, the RASV reserves the right to forfeit an award.

**JUDGING**

352. The following Regulations shall be read subject to Regulations 10.1 through to 11.8 inclusive of the General Regulations.

a). Judging dates of Exhibits are as follows:

Boer Goats: Saturday 21 September 2013 from 3:00pm

Dairy Goats: Wednesday 25 September 2013 from 9:30am

A ribbon may be awarded, at the Judges discretion, to place getters in all classes.

b). Exhibitors of goats shall be present at the appropriate Judging Ring at least 15 minutes prior to the time specified in the timetable for judging to take place. They must have their Exhibits ready for judging, and enter the Judging Ring immediately upon request by the appropriate steward(s).

c). Attendants leading goats in the Judging Ring or on parade must wear uniform white coats and the Exhibit number of the goat. Exhibitors must collect these numbers from the Superintendent's Office.

d). Persons in charge of Exhibits at or in the Judging Ring shall not address the Judge unless authorised by the Steward in Charge or the Judge himself.

353. After judging is completed, only prize-winning goats are permitted to take part in parades. All prize-winning Dairy goats must be taken out on parade, in accordance with the printed program. Prize-winning Angoras may also be paraded provided they can be suitably led.

354. In any parade prior to judging, goats are to be paraded according to the following formula:

1-3 head exhibited:	1 head paraded
4-6 head exhibited:	2 head paraded
over 6 head exhibited:	3 head paraded

355. No ribbons will be permitted on the Exhibits on parade, except those won during the 2013 Royal Melbourne Show.

356. Persons in charge of Exhibits must in no circumstance leave their Exhibits unattended at or in the Judging Ring.

**RUGGING**

357. Exhibits must not be rugged during the hours the Show is open to the public. Exhibitors will be liable to a fine of \$50.00 for every infringement of this regulation.

**PRIZES**

358. Ribbons may be awarded up to 6th place as follows:

1 to 10 Exhibits per class:	1 <sup>st</sup> , 2 <sup>nd</sup> & 3 <sup>rd</sup> ribbons.
11 to 20 Exhibits per class:	1 <sup>st</sup> , 2 <sup>nd</sup> , 3 <sup>rd</sup> & 4 <sup>th</sup> ribbons.
Over 20 Exhibits per class:	1 <sup>st</sup> , 2 <sup>nd</sup> , 3 <sup>rd</sup> , 4 <sup>th</sup> , 5 <sup>th</sup> & 6 <sup>th</sup> ribbons.



359. Judging is subject to General Regulation 10. The Judge is under no obligation to award the prizes listed in the table where he considers in his absolute discretion that such prize or prizes are not to be awarded.

360. The colour of each ribbon will be as follows: 1<sup>st</sup> Blue, 2<sup>nd</sup> Red, 3<sup>rd</sup> White, 4<sup>th</sup> Yellow, 5<sup>th</sup> Green, 6<sup>th</sup> Brown, 7<sup>th</sup> Lime Green, 8<sup>th</sup> Orange, Highly Commended Lavender

**PAYMENT OF PRIZE MONEY**

361. Prize money as stated in the relevant Prize Schedule includes GST, if applicable.

362. The RASV has allocated prize money to Ordinary classes for each breed. No money is allocated to Special or Group classes unless otherwise stated.

## GENERAL REGULATIONS FOR ALL COMPETITIONS

### 1. DEFINITIONS AND INTERPRETATION

#### 1.1 Definitions

The following definitions apply unless the context requires otherwise.

**Agent** includes any person, agent, association or corporation engaged by or on behalf of the Exhibitor and any person acting or purporting to act on the Exhibitor's behalf (including any person who is an invitee of the Exhibitor and regardless of whether the person is remunerated or not).

**Assistant Chief Steward** means the person occupying or acting in the position of Assistant Chief Steward of a section.

**Body** includes any society, organisation or body within or outside Australia having similar objects to the RASV and, without limitation, includes:

- Royal Agricultural Society of the Northern Territory Inc;
- Royal National Agricultural & Industrial Association of Queensland;
- Royal Agricultural & Horticultural Society of South Australia;
- Royal Agricultural Society of NSW;
- Royal Agricultural Society of Tasmania;
- Royal National Capital Agricultural Society;
- Royal Agricultural Society of WA; and
- any breed association or society recognised by the RASV.

**Business Day** means a week day on which banks in Melbourne are open for business.

**Chief Executive Officer** means a person occupying or acting in the position of Chief Executive Officer of the RASV.

**Chief Steward** means the person occupying or acting in the position of Chief Steward of a section.

**Closing Date** means the date and time set out in the Relevant Schedule after which entries for the Event will not be accepted by the RASV.

**Drug** has the meaning set out in the Relevant Schedule.

**Entry Form** means an entry form supplied by the RASV for an Event.

**Event** includes competition and class and without limitation includes any event listed in a Schedule.

**Exhibit** means the animal, person or item entered into an Event by an Exhibitor.

**Exhibitor** means the owner, and if the owner is less than 18 years of age, the parent or guardian of the owner who signs the Entry Form.

**Judge** means a person appointed by the RASV to judge an Event.

**Motor Vehicle** includes a truck, trailer, horse float and stock transporter but does not include a caravan.

**RASV** means The Royal Agricultural Society of Victoria Limited (ACN 006 728 785).

**Regulations** means:

- (a) the RASV's General Regulations For All Competitions;
- (b) the rules, regulations and conditions of entry set out in the Relevant Schedule; and
- (c) the rules, regulations and conditions of entry set out on the Entry Form for the Event.

**Relevant Schedule** means the Schedule which applies to the particular Event in which the Exhibitor has submitted or proposes to submit an entry in accordance with these Regulations.

**Schedule** means a Schedule of events and prizes issued by the RASV and without limitation, a reference to a Schedule includes a reference to the rules, regulations and conditions set out in the Schedule.

**Show** means the Royal Melbourne Show.

**Showgrounds** means the Melbourne Showgrounds, Epsom Road, Ascot Vale, Victoria and includes without limitation all areas owned, used, rented or leased by the RASV.

**Steward** means a person occupying or acting in the position of steward.

**Veterinary Surgeon** means a veterinary surgeon appointed by the RASV.

#### 1.2 Interpretation

Headings are for convenience only and do not affect interpretation. The following rules apply unless the context requires otherwise.

- (a) The singular includes the plural and conversely.
- (b) A gender includes all genders.
- (c) If a word or phrase is defined, its other grammatical forms have a corresponding meaning.
- (d) A reference to a person, corporation, trust, partnership, unincorporated body or other entity includes any of them.
- (e) A reference to a Regulation is a reference to a regulation of these Regulations.
- (f) A reference to a regulation, rule or condition of entry is to the regulation, rule or condition of entry as amended, varied, supplemented, novated or replaced, except to the extent prohibited by these regulations.
- (g) A reference to a right or obligation of any two or more persons confers that right, or imposes that obligation, as the case may be, jointly and severally.

In the event of an inconsistency between the Regulations and a Schedule, the Regulations prevail to the extent of the inconsistency unless otherwise provided.

#### 1.3 Exemptions

The RASV may, by notice in writing, exempt an Exhibit or an Exhibitor from one or more of the obligations or requirements contained in these Regulations.

#### 1.4 Consents or Approvals

Where the doing of any act, matter or thing under these Regulations is dependent upon the consent or approval of a person or is within the discretion of a person, the consent or approval may be given or discretion may be exercised conditionally or unconditionally or withheld by the person in its absolute discretion and without giving or assigning any reason for it.

### 2. ENTRIES

#### 2.1 Requirements for entering an Event

An entry to an Event must be:

- (a) in writing;
- (b) on an Entry Form;
- (c) signed by the Exhibitor or, if the Exhibitor is less than 18 years of age, signed by the Exhibitor's parent or guardian;
- (d) accompanied by the entry fee set out in the Relevant Schedule; and
- (e) submitted before the Closing Date to the RASV's Registered Office.

#### 2.2 Warranty

The Exhibitor represents and warrants to the RASV that the information set out on the Entry Form is complete, accurate and not misleading in any way.

#### 2.3 Rules and Regulations

An entry is subject to:

- (a) the Regulations;
- (b) the Relevant Schedule; and
- (c) the rules, regulations and conditions set out on the Entry Form.

#### 2.4 Entries subject to Rules and Regulations

Upon submission of an entry in accordance with Regulation 2.1, the Exhibitor agrees to be bound by the rules, regulations and conditions referred to in Regulation 2.3 and to ensure that each Agent of the Exhibitor complies with those rules, regulations and conditions. An act or omission of an Agent of an Exhibitor may be deemed by the RASV to be the act or omission of the Exhibitor.





- 2.5 Altered Entries**  
Subject to the Relevant Schedule, an entry may not be altered after the Closing Date.
- 2.6 Number of Entries**  
The RASV may restrict the number of entries in any Event.
- 2.7 Limit on entry into multiple Ordinary Classes**  
Subject to the Relevant Schedule, an Exhibit must not be entered in more than one Ordinary Class. Should any Exhibit be sought to be entered in more than one Ordinary Class, the Exhibit will only compete in the Ordinary Class in which the Exhibit's or the Exhibitor's name first appears in the RASV's Catalogue unless the RASV otherwise directs. For the purposes of this Regulation, Sweepstakes, Special Classes, Trophy Classes and Championships are not an Ordinary Class. 'Ordinary Class', 'Sweepstakes', 'Special Class', 'Trophy Class' and 'Championship' have the meaning given in the Relevant Schedule.
- 3. ENTRY AND NOMINATION FEES**  
The entry fee and, if applicable, the nomination fee, become the property of the RASV on receipt by the RASV and, without limitation, the entry fee and, if applicable, nomination fee paid in respect of an entry which is withdrawn or which does not satisfy the requirements for entry or conditions of eligibility will not be refunded.
- 4. OWNERSHIP OF EXHIBITS**
- 4.1 Ownership on entry**  
At the time the RASV receives the Entry Form for entry to an Event, the Exhibit entered into that Event by the Exhibitor must be the property of the Exhibitor or held by the Exhibitor under a written lease in existence at that time.
- 4.2 Ownership on judging**  
At the time of judging an Event, each Exhibit entered into that Event by an Exhibitor must be the property of the Exhibitor or be held by the Exhibitor under a written lease in existence at that time. An Exhibit which is not the property of the Exhibitor or held by the Exhibitor under a written lease in existence at the time of judging will be ineligible for the Event.
- 5. EXHIBITION OF EXHIBITS**
- 5.1 Grounds for not exhibiting**  
The Exhibitor must not withdraw an Exhibit from an Event, and an Exhibit must be exhibited, unless a certificate signed by a veterinary surgeon is lodged with the RASV certifying that the Exhibit is unable to compete for one or more of the following reasons:
- (a) the Exhibit, being an animal, has died;
  - (b) the Exhibit, being an animal, is unfit to be exhibited due to injury or disease;
  - (c) the Exhibit is ineligible for the Event; or
  - (d) some other cause the RASV considers reasonable.
- 5.2 Time for withdrawing Exhibit**  
A certificate given under Regulation 5.1 must be given to the RASV:
- (a) before the date for admission of the Exhibit to the Showgrounds (as set out in the Relevant Schedule), if the cause for withdrawal of the Exhibit occurs or arises before that date; or
  - (b) otherwise, as soon as possible after the cause for withdrawal of the Exhibit occurs or arises.
- 5.3 Training or preparing Exhibits or Exhibitors**  
Exhibitors must not enter into an Event that is to be judged by a person who has trained or prepared the Exhibitor or Exhibit within six months of the date of the Event.
- 6. EXHIBIT TICKET**  
Subject to the Relevant Schedule, the RASV will issue an exhibit ticket for an Exhibit unless it otherwise determines. The Exhibitor or an Agent of the Exhibitor must produce the exhibit ticket upon a request from the RASV or a Steward.
- 7. CONDUCT OF EXHIBITORS AND AGENTS**
- 7.1 Compliance with rules and regulations**  
Where an Exhibit and/or Exhibitor and/or an Agent fails to comply with any of the Regulations the RASV may impose one or more of the following penalties on the Exhibit or Exhibitor or both of them:
- (a) disqualification;
  - (b) suspension;
  - (c) a fine;
  - (d) order the Exhibit or the Exhibitor, his or her family, invitees and Agents be removed from the Showgrounds; or
  - (e) any other penalty.
- Without limiting the above, the RASV may forfeit an award, and upon forfeiture, the Exhibitor must return any ribbon, money, prize card or other evidence of that award to the RASV within seven days after receiving notification of the forfeiture. Nothing in this Regulation limits Regulation 8.
- 7.2 Compliance with directions**
- (a) The Exhibitor and/or Agent must fully comply with the directions and requests of the RASV. Without limitation, directions and requests of the RASV may apply to the Exhibit, the Exhibitor, the Agent, the conditions of the Event, the conduct of the Exhibitor, the conduct of the Event, the conduct of the Agent, the decision of the Judge, or the award of prizes.
  - (b) Without limiting Regulation 7.2(a), upon a request from the RASV, an Exhibitor and/or Agent must make a statutory declaration in the form and with respect to matters the RASV in its discretion requires.
  - (c) Without limiting Regulation 7.2(a), upon a request from the RASV, an Exhibitor and/or Agent must submit his or her Exhibit for inspection by a Veterinary Surgeon.
- 7.3 Statements**  
The Exhibitor and/or Agent must not make a statement regarding an Exhibit, which in the opinion of the RASV, is fraudulent, false, erroneous, misleading or deceptive or likely to mislead or deceive.
- 7.4 Tampering**  
An Exhibit must not be or have been tampered with or otherwise improperly dealt with by an Exhibitor.
- 7.5 Animals and livestock**  
Unless the RASV gives prior written approval, pets, animals or livestock other than Exhibits must not be brought onto or permitted to enter or remain on the Showgrounds.
- 7.6 Mutual Recognition**  
The RASV may recognise, act upon and enforce any penalty imposed by a Body on an Exhibit or Exhibitor or Agent at any time.
- 7.7 Further Proceedings**  
The RASV may conduct further proceedings in relation to any matter concerning an Exhibitor, an Exhibit, an Agent, a potential Exhibitor, or a potential Exhibit, and impose any suspension, fine, disqualification, withdrawal or forfeiture of an award, handicap, reprimand, warning or any other penalty, irrespective of whether a Body has already imposed a penalty on the Exhibitor or the Exhibit or Agent, or on the potential Exhibitor or the potential Exhibit.
- 7.8 Reciprocal Arrangements**  
The RASV may enter into reciprocal arrangements with a Body in relation to any matter concerning an Exhibit, an Exhibitor, an Agent, a potential Exhibit or a potential Exhibitor.
- 8. POWERS OF RASV IN RESPECT TO CONTROL OF THE SHOW**
- 8.1 Power to refuse to accept an Entry, Exhibit or Exhibitor**  
The RASV may refuse to accept an entry for an Event, an Exhibit or an Exhibitor or any of them.
- 8.2 Power to cancel or alter**  
The RASV may:
- (a) alter the Closing Date for an Event, or the Closing Date for receipt of any particular entry;
  - (b) remove any Exhibit from the Showgrounds or cause any Exhibit to be removed from the Showgrounds;
  - (c) amend an entry for an Event to, without limitation, substitute an alternate competition or class for the competition or class in which the Exhibit is or was entered;
  - (d) alter the conditions of any Event;



- (e) refuse to display an Exhibit;
- (f) rule that an Exhibit or Exhibitor may not compete or is ineligible to compete;
- (g) alter the date, time or place on or at which any Event is scheduled to take place or to be judged;
- (h) alter the Judge scheduled to judge any Event; or
- (i) cancel any Event.

The rights set out above apply notwithstanding:

- (a) the RASV's acceptance of an entry for an Event;
- (b) inclusion of an entry for an Event in the Show Catalogue;
- (c) the issue of an exhibit ticket to an Exhibitor or in respect of an Exhibit or an Event; or
- (d) the issue of any other document to an Exhibitor or in respect of an Exhibit or an Event.

## 9. VETERINARY SERVICE

### 9.1 Animal Health Status

If the Exhibitor or any Agent of the Exhibitor detects or suspects any illness amongst any of his/her Exhibits whilst the Exhibits are at the Showgrounds, the Exhibitor must:

- (a) report this fact immediately to the representative of the RASV responsible for the applicable livestock section (the **Superintendent**);
- (b) ensure that the Exhibit(s) concerned is/are contained within the space allocated by the RASV for the Exhibit(s), unless advised otherwise by the Superintendent or a member of the RASV veterinary panel on duty; and
- (c) where feasible to do so, contain soiled bedding from the Exhibit(s) concerned within the space allocated by the RASV for the Exhibit(s).

The Exhibitor may engage or consult a private veterinary surgeon in respect to the illness only after the above action has been taken and only after first consulting with a member of the RASV veterinary panel on duty.

### 9.2 Treatment upon illness or injury

If an Exhibit is ill or injured, a Veterinary Surgeon may in his or her discretion attend to or treat the Exhibit. The Veterinary Surgeon may do so even in the absence of authority from the Exhibitor, or contrary to that authority.

### 9.3 Destruction or Removal

Where, in the opinion of a Veterinary Surgeon, an Exhibit should be destroyed or removed from the Showgrounds:

- (a) the Veterinary Surgeon or any other person approved by the RASV may destroy or remove the Exhibit from the Showgrounds, or both; or
- (b) the RASV may require the Exhibitor to immediately destroy or remove the Exhibit from the Showgrounds or both.

All costs and expenses incurred by the RASV pursuant to this Regulation must be reimbursed by the Exhibitor to the RASV. Nothing in this Regulation limits Regulation 8.2.

### 9.4 Veterinary Surgeons

Where an Exhibitor wishes to engage or consult a veterinary surgeon who is not appointed by the RASV, the Exhibitor must first inform the representative of the RASV responsible for the applicable livestock section. A Veterinary Surgeon, a Judge and the RASV itself is not required to have regard to or to consider any opinion of a veterinary surgeon so engaged or consulted by the Exhibitor, and a decision of a Veterinary Surgeon, a Judge or the RASV is final regardless of whether or not the Exhibitor has engaged or consulted a veterinary surgeon not appointed by the RASV.

## 10. JUDGING

### 10.1 Interference

The Exhibitor and Agents of the Exhibitor must not consult, influence or interfere with a Judge or attempt to consult, influence or interfere with a Judge or do any other thing which may influence or interfere with the Judge's freedom of choice or judgement unless it is expressly authorised by the Relevant Schedule.

Unless with the permission of the RASV no Exhibitor or Agent of an Exhibitor may occupy the position of Judge or become in any way identified with the judging or handling of Exhibits in any class in which that person or that person's employers are interested. This does not apply to Stewards.

### 10.2 Indications of Ownership

The Exhibitor, any Agent of the Exhibitor and the Exhibit must not be equipped with or wear or display anything indicating the ownership of the Exhibit before or during judgment of the Exhibit unless it is expressly authorised by the Relevant Schedule.

### 10.3 Decision

Except as otherwise expressly provided in the Regulations, the decision of a Judge as to the merits of the Exhibit and the Exhibitor or either of them will be final, and the Exhibitor may not protest or appeal the decision.

### 10.4 Prizes

Subject to the Relevant Schedule, a Judge may in his or her opinion:

- (a) award a second or third prize in place of a first prize;
- (b) withhold a prize where a prize should not be awarded;
- (c) where there is a tie for any placing in an Event, award subsequent placings so that the next placing will be the number of Exhibits already placed plus one (for example, if two Exhibits tie for first place, award a third for the next placing);
- (d) where all the prizes offered in an Event have been awarded and a further Exhibit is of sufficient merit to deserve a prize make a reserve number of the further Exhibit; or
- (e) give commendations where they are deserved.
- (f) award an Exhibitor more than one prize in any class where more than one entry is permitted.

### 10.5 Disqualifications

Where an Exhibit or an Exhibitor is disqualified and the applicable award is forfeited, the RASV may (but is not obliged to) promote the Exhibit next in order to that prize, whether the Exhibit next in order was awarded a prize or a reserve number. Exhibits next in order, whether awarded a prize or reserve number, may also be promoted to the prize next in order.

### 10.6 Prize Cards

The Exhibitor must ensure that prize cards awarded for an Exhibit are displayed with the Exhibit while it is on exhibition.

## 11. PROTESTS AND APPEALS

Protests and appeals may only be made by Exhibitors with Exhibits in the class to which the protest relates.

### 11.1 Protest to Stewards

The Exhibitor may protest to either (but not both) the Chief Steward or Assistant Chief Steward of the relevant section in relation to conduct, judging or any other matter relating to an Event. A protest must be made in accordance with the procedures set out in the Relevant Schedule and be received by the Chief Steward or Assistant Chief Steward (as applicable) within 24 hours after the conclusion of the applicable Event.

### 11.2 Appeal

The Exhibitor may appeal against:

- (a) a decision made by the RASV pursuant to Regulations; or
- (b) a decision of the Chief Steward or Assistant Chief Steward in relation to a protest under Regulation 11.1.

### 11.3 Form of Appeal

To be an appeal for the purpose of Regulation 11.2 an appeal made by the Exhibitor must be:

- (a) in writing setting out in reasonable detail the grounds for the appeal;
- (b) addressed to:
  - The Chief Executive Officer
  - The Royal Agricultural Society of Victoria Limited
  - Administrative Building
  - Melbourne Showgrounds
  - Epsom Road, Ascot Vale, Victoria, 3032;
- (c) accompanied by a deposit of \$200.00 (or such other amount as is notified from time to time by the RASV for the purpose of this Regulation 11.3(c)); and
- (d) received by the Chief Executive Officer by 5 p.m. on the Business Day which is 10 Business Days after the day on which the decision the subject of the appeal was made.

### 11.4 Review Committee

For the purposes of this Regulation: a "Review Committee" will be comprised of three people selected by the RASV, being persons who were not part of, and who are independent of, the committee or personnel who made the decision the subject of the appeal.



Within a reasonable time after receipt by the Chief Executive Officer of an appeal complying with Regulation 11.3, the Review Committee will meet to consider the appeal.

## 11.5 Proceedings of the Review Committee

In considering an appeal, the Review Committee must:

- (a) give due consideration to the grounds of appeal submitted by the Exhibitor, and to any other evidence submitted by the Exhibitor;
- (b) give the Exhibitor an opportunity to make oral representations to the Review Committee; and
- (c) in its discretion, call for and hear expert opinion.

## 11.6 Notification of Review Committee's decision

The Chief Executive Officer will notify the Exhibitor of the Review Committee's decision within 48 hours after that decision is notified by the Review Committee to the Chief Executive Officer. The decision of the Review Committee is final and the Exhibitor will not have any right of appeal in respect of the Review Committee's decision.

## 11.7 Forfeiture of deposit

Where an appeal is upheld by the Review Committee, the deposit referred to in Regulation 11.3 will be refunded to the Exhibitor when or within a reasonable time after the decision of the Review Committee is notified by the Chief Executive Officer to the Exhibitor. Where an appeal is not upheld by the Review Committee, the deposit referred to in Regulation 11.3 will be retained by the RASV.

## 12. ACCOMMODATION

### 12.1 No obligation to provide Exhibit space or accommodation

- (a) The RASV is not obliged to provide space for an Exhibit or accommodation for an Exhibitor or any Agent of an Exhibitor. For the purposes of these Regulations, "accommodation" includes provision of a space for a person to sleep.
- (b) Where the RASV, in its discretion, allocates space for an Exhibit or accommodation for an Exhibitor or any Agent of an Exhibitor, only the allocated areas may be used, and only for the purpose designated by the RASV.

### 12.2 Personal effects

The RASV has no responsibility or liability for any loss or damage:

- (a) suffered by an Exhibitor or any Agent of an Exhibitor using space provided for an Exhibit or accommodation for an Exhibitor or any Agent of an Exhibitor; or
- (b) caused to personal belongings, equipment or property which is brought onto the Showgrounds by an Exhibitor or any Agent of an Exhibitor.

## 13. FIRE REGULATIONS

### 13.1 Flames

The Exhibitor and any Agent of the Exhibitor must not smoke, cook, or heat water by any means whatsoever or use any device involving naked flame in or near any animal pavilion, stall, pen or locker.

### 13.2 Electrical Interference

The Exhibitor and any Agent of the Exhibitor must not:

- (a) subject to Regulation 13.3, use mains powered electrical devices in or near any animal pavilion, stall, pen or locker; or
- (b) alter or interfere with any electrical wiring, switch, plug or socket whatsoever on the Showgrounds.

## 13.3 Exceptions

Nothing in Regulation 13.2(a) prohibits the use of main powered electrical appliances which are, in the opinion of the RASV, essential to animal care, or the use of a light-bulb in a locker if the light-bulb is fitted in the socket provided.

## 14. VEHICLE PARKING

### 14.1 Loading and Unloading

With the prior consent of the RASV, Motor Vehicles of an Exhibitor or an Agent of an Exhibitor may enter the Showgrounds, or any area under RASV control, for the purpose of loading or unloading only. Motor Vehicles must not remain on the Showgrounds, or any area under RASV control, and must be removed immediately upon completion of loading or unloading.

### 14.2 Caravans

Caravans of an Exhibitor or an Agent of an Exhibitor must not enter or remain on the Showgrounds, or any area under RASV control, for any purpose, unless in accordance with the prior written consent of the RASV.

### 14.3 Tow Away

Any Motor Vehicle or Caravan entering or remaining on the Showgrounds, or any area under RASV control, in contravention of the Regulations or of any other parking rules or restrictions, may be removed from the Showgrounds, or any area under RASV control, by the RASV and stored. Any costs incurred by the RASV pursuant to this Regulation must be paid by the Exhibitor.

## 15. LIABILITY AND INDEMNITY

### 15.1 Release

Entry to, remaining on and using the Showgrounds or any part of them by an Exhibitor is entirely at the risk of the Exhibitor and, to the maximum extent permitted by law, the Exhibitor releases the RASV (which term includes in this clause the RASV's officers, employees, members, contractors and agents), from all claims, demands and liabilities of every kind resulting from any accident, damage, injury or illness occurring at the Showgrounds and, without limitation, the Exhibitor acknowledges and agrees:

- (a) the RASV has no responsibility or liability for any loss, damage, injury or illness to or caused by any Exhibit;
- (b) the RASV has no responsibility or liability for any loss, damage, injury or illness to or caused by any Exhibitor or any Agent;
- (c) the RASV has no responsibility or liability for any loss or damage to a Motor Vehicle or any of its contents whilst it is on the Showgrounds or in any car park under the RASV's control; and
- (d) without limiting Regulations 15.1 (a) and 15.1 (b) above, the RASV has no responsibility or liability for any loss, damage, injury or illness resulting from the sale, treatment, failure to treat, destruction, disposal or other dealing with any Exhibit, or for any loss, damage or injury to any personal belongings, equipment or property brought onto the Showgrounds by any person.

### 15.2 Indemnity

To the maximum extent permitted by law, the Exhibitor must indemnify and keep indemnified the RASV and its officers, employees, members, contractors and agents from and against all actions, claims, demands, losses, damages, costs, expenses and liabilities including without limitation, consequential loss and loss of profits for which the RASV is or may be or become liable in respect of or arising from:

- (a) loss, damage, injury or illness to any person in connection with the Exhibit or the relevant Event;
- (b) without limiting Regulation 15.2(a), loss, damage, injury or illness to any other Exhibit or Exhibitor, or any Agent of any other Exhibitor, or to the property of the RASV, or its members, or to the general public, or any member of the general public, caused or contributed to or by any act or omission of an Exhibit of the Exhibitor or by the Exhibitor or any Agent of the Exhibitor; and



- (c) without limiting Regulation 15.2(a), loss, damage, injury or illness to the Exhibit, or to the Exhibitor or any Agent of any other Exhibitor caused or contributed to by an act or omission of an Exhibit or by the transportation, feeding or housing of an Exhibit.

## 15.3 Removal from Showgrounds

Without prejudice to any other provision in these Regulations, where the RASV, its officers, employees, members, contractors or agents removes an Exhibit, or causes an Exhibit to be removed from the Showgrounds, the Exhibit is removed or caused to be removed entirely at the risk of the Exhibitor. The person or persons removing the Exhibit will be deemed to be the agent of the Exhibitor, and his or her acts and omissions will be deemed to be the acts and omissions of the Exhibitor.

## 16. INSURANCE

The RASV may arrange owner's liability insurance cover for Exhibitors of Exhibits that are animals, and, if the RASV does so, the Exhibitor is bound by the terms and conditions of this insurance and by applicable duties of an insured under the Insurance Contracts Act (1984). Details of owner's liability insurance cover arranged by the RASV are set out in the Relevant Schedule.

## 17. INFORMATION HANDLING

The RASV is bound by the National Privacy Principles of the *Privacy Act 1988* (Cth) and other applicable laws governing privacy.

### 17.1 Collection of Personal Information

- (a) The RASV may collect, hold and use personal information about Exhibitors, their family members, invitees or Agents.
- (b) The types of information that may be collected include names and contact details, credit card details, qualifications, results of the Exhibitor's entry into the relevant Event and any reprimand, fine, disqualification, withdrawal of an award or penalty imposed on the Exhibitor in connection with entry of the Exhibit in the relevant Event. Information may also be collected from other Bodies relating to the Exhibitor's entry into events held by that Body including, without limitation, reprimands, fines, disqualifications, withdrawals of awards or penalties imposed.
- (c) Personal information is collected for the purpose of administration of Events and the Show, as well as related purposes including, without limitation, promoting the Events and the Show, maintenance of records of information relevant to qualifications for future events, maintenance of health and safety records in relation to Events, applicable insurance cover for Events and making claims under the RASV's insurance for incidents which involve an Exhibitor and occur during an Event.
- (d) Personal information may also be used for the purpose of informing Exhibitors about other events and services offered by the RASV (such as future Shows) by post. The RASV may send an Exhibitor publications and information about other events and services electronically, if the Exhibitor provides an email address for this purpose.

### 17.2 Sharing Personal Information

- (a) The RASV may share information with other organisations and service providers to assist in administering the Events and the Show, including co-sponsors of Events and health service providers, indemnity or insurance providers or other Bodies, or any entity that may subsequently administer the Show.
- (b) The RASV may also publish winners details on its websites or publications or disclose information about an Exhibitor to the media for the purpose of publishing articles on the Exhibitor's participation in the Show, unless the Exhibitor has requested that the Exhibitor's personal information not be published or disclosed for these purposes.
- (c) The RASV may also disclose information if otherwise required or authorised by law.

## 17.3 Access And Correction

- (a) An Exhibitor may contact the RASV if the Exhibitor has a complaint or a query about the information handling practices of the RASV.
- (b) An Exhibitor may request that the RASV remove any personal information about that Exhibitor published in connection with an Exhibit or an Event from the RASV's publications. The RASV will, to the extent that it can reasonably do so and as soon as is reasonably practical, remove such information from the relevant publications.
- (c) An Exhibitor may request the RASV to provide access to any personal information held by the RASV about the Exhibitor, to the extent authorised by the Privacy Act and all other applicable laws. Those laws may not give rise to a right of access to all information or in all circumstances.

## 18. AGENTS

Any person acting or purporting to act as an agent of an Exhibitor is deemed to have given the RASV a warranty of his or her authority to so act, and the RASV is not required to make any inquiry as to that authority.

## 19. GOVERNING LAW

These Regulations are governed by the laws of Victoria.
